On the 28th of January, National Content visited the Makerere and UPIIK institutions with EACOP's Thermal Insulation System (TIS) contractor ISOAF. The engagement was aimed at introducing the contractor to the universities and recommend possibilities for synergy between the institutions and ISOAF on the different works carried out by the contractor.



On January 29th to February 4th, 2023, The Petroleum Authority of Uganda (PAU) and The Energy, Water, and Utilities Regulatory Authority (EWURA) management teams accompanied by EACOP's representatives, amongst them a member from Local Content, conducted a supervisory site inspection along the EACOP's pipeline route in Tanzania.

On the 9th of February, a member of the Local Content team alongside EACOP's MLC contractor EALS Bollore visited the Dar es Salaam Maritime institution for the purpose of potential collaboration on train the trainer programs.



On February 15th to 17th, Local Content took part in the Inauguration Ceremony of EACOP's tanks and terminal contractor DOCG in Tanga. The ceremony was prepared for the launch of DOCG training program in the fields of welding and H3SE. Trainings will be conducted by DOCG contractor – Sunmaker Development and Consulting Tanzania Limited, in collaboration with Arusha Technical College and VETA Institution in Tanga.

On February 21st, Tanzania's Minister for Energy, January Makamba, handed over the certificate of approval to the East African Crude Oil Pipeline Project (EACOP) for the construction of a 1,147 km pipeline. As part of Local Content pillars, the project is expected to provide employment, goods and services opportunities as well as stimulate economic growth across both countries.



On the 24th of February, members of EACOP's Lifting, Local Content, and Regulatory Compliance were invited by The National Council for Technical and Vocational Education and Training (NACTVET) to a gala dinner event at the Hyatt Regency Hotel in Dar es Salaam. The event was geared towards addressing ongoing collaboration activities between NACTVET and EACOP in resolving issues of skills challenges observed in lifting equipment and other occupations and developing a standardized Training Framework for lifting equipment and other occupations.



On February 27th to March 1st, EACOP National Local Content team accompanied by the chairman, members, and management of the board of Energy, Water and Utility Regulatory Authority (EWURA) engaged in a cross border pipeline route inspection. The tour was geared towards familiarizing the board with the progression of ongoing activities along the pipeline route. The inspection started at Singida region in Tanzania and ended in Kabaale Industrial Park in Uganda.
