The goal is to convey practical information about the current field activities, facilitating engagement and keeping the Regional Authorities informed.

## **PROJECT CONSTRUCTION**



#### Pipeline, Early Civil Works (ECW) of the Main Camps and Pipeyards (MCPY)

- CPP Pipeline Crossings Survey (57 sites) continues, completion in November 2023.
- Project Lot 2 Main Line Block Valve (MLBV) access road survey completed • October.
- JV Spek Early Civil Works (ECW) MCPY-16 continues, completion February 2023, works progress affected by Elnino rains.
- CPP MCPY-15 camp construction is ongoing.
- ECW MCPY-10, 09, 08, 06& 11 is completed, all sites handed over to • CPP.

## LAND ACQUISITION UPDATES

#### **Compensation Agreements Signing**

As of November 2023, 9,433 out of 9,514 (99%) pipeline Project-Affected Persons (PAPs) have completed compensation agreement signing, and all have received their compensation.

An Escrow review panel has been assembled to discuss the due diligence of an absent PD PAP from Geita who claimed her entitlements one year after the EBCA process. The escrow panel provided the green light for the EBCA to proceed. An Entitlement Briefing was conducted on 2nd December 2023, and Compensation Agreement signing is expected on 18th December 2023.

#### **Transitional Support Services**

November Cash allowance transfers completed for zone 1 and 3 regions (Kagera, Geita, Shinyanga and Tanga regions). Cash allowance transfers for the remained regions to proceed in December 2023.

#### **Pipeline Relocation Assessment and Support**

As of the latest update, 9,513 out of 9,514 Pipeline Project-Affected Persons (PAPs) have completed relocating from the project area. However, three PAPs have not yet finished relocating.

Specifically, one PAP at Sagida Village, Nzega District, Tabora Region, is awaiting additional relocation support to complete the relocation of the spiritual site. Additionally, two PAPs at Ilindi Village, Kahama District, Shinyanga Region, are in the process of relocating surface mining facilities.

263 out of 263 Pipeline physically displaced PAPs who selected replacement houses (RH) have received and completed relocating to their new replacement houses.

The handover ceremony of the last replacement house was successfully conducted at Songakibaoni village, muheza District, Tanga region on 28th November 2023.

#### **Pipeline Grave Removal**

1,083 out of 1,087 (99.6%) Pipeline Graves have been removed. 4 graves confirmed as not removed due to: 1 grave avoided so to be removed from figures, 1 incomplete ritual performance in Geita, 1 family conflict in Singida over the impacted assets including grave, 1 unpaid compensation for grave in Muleba.

#### **Pipeline Cadastral Survey**

The Ministry of Land, Housing, and Human Settlement Development (MLHHSD) and the Tanzania Petroleum Development Corporation (TPDC), with the support of EACOP personnel, have conducted a cadastral survey exercise across all eight project-affected regions. The fieldwork exercise has been completed 100%.

## LIVELIHOOD RESTORATION

## Livelihoods Restoration Program (LRP)

#### **PPL** implementation.

#### VUNA Agribusiness: LRA 1-3 (Land preparation and planting, Maize Improvement and Crops diversification).

As of November 2023, the implementation of LRA 1-3 is underway in Kagera, Tabora, and Shinyanga for G1-4. Meetings have been conducted to disseminate crucial information about entitlements to eligible households affected by the project. Further details on the number of Project Affected Households (PAHs) prepared for planting this season will be communicated later. Progress is evident in Module 1 & 2 training, land preparation, planting, maize improvements, and crop diversification.

In Kagera, Module 3 training (crop protection) for LRA 1-3 has been successfully completed. The crops planted, including maize, bananas, and beans, are exhibiting robust growth. To bolster crop disease management, Module 3 training on crop protection has been conducted. A noteworthy 841 out of 1847 PAHs (45.5%) have undergone training in Module 3 on crop protection. Continuous extension services from field-based staff are being provided to support PAHs in their agricultural endeavors.

#### Conservation Farming Unit (CFU) Contractor Kickoff of LRA 1-3 (Land preparation and planting, maize improvement, and crops diversification)

The inaugural meeting for the LRA 1-3 contract, focusing on work packages 3 and 4, was convened in Dar to signal the initiation of these activities for eligible Project Affected Households (PAHs) in Singida, Manyara, Dodoma, and Tanga.

CFU has been awarded the contract for work packages 3 and 4 to execute the LRA 1-3 implementation across the specified regions. The LRA scoping is slated for early December to pave the way for the commencement of agricultural activities. Due to

#### LRA4 (Poultry improvement program)

Zakayo Daudi, a Project Affected Person a resident of Njoro village in the Kiteto district, chose to engage in poultry farming. Initially, he received five chicks from EACOP and underwent training in enhanced poultry farming practices.

Demonstrating dedication to his venture, Zakayo expanded his chicken coop to accommodate a larger flock. Presently, he owns a total of 50 chickens, acquired through the proceeds from selling maize with support from EACOP. His overarching goal is to supply eggs and chicken meat to the camp located in Kiteto as part of his long-term plan.

## **REPLACEMENT HOUSING**

- All 296 houses are complete and have been handed over to their respective PAPs with a global construction progress at 100%.
- Replacement houses have been fully constructed in regions of Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga.
- A total of 1147 continuous kilometres of pipeline have been cleared of all housing activities.
- An additional 57 kilometres, which are not in continuous succession, have been cleared of all housing-related activities.

#### Notable progress in the month of November 2023 includes:

- The handover of 34 houses to their respective PAPs.
- Completion of house construction in the region of Tanga.
- The conclusion of the house construction marks the beginning of a one-year warranty period. During this from the replacement houses.

the impact of El Niño, the Tanga region witnessed an earlier onset of rainfall than originally projected. Consequently, the contractor has opted to defer the commencement of agricultural activities for this season until February 2023.

The postponement aims to allow sufficient time for scoping and planning, ensuring a well-prepared engagement with Project Affected Households (PAHs) for the first season in Tanga.

## STAKEHOLDER ENGAGEMENT – GOVERNMENT AND COMMUNITY

The main engagement topic for this month is still transitional support services for pipeline PAPs. A total of 334 meetings were held in various communities, bringing together 7,125 stakeholders out of whom 36% were women.

#### **High-level CSO Engagement**

EACOP was honored to participate in the largest gathering of civil societies in Tanzania. The CSO week sets the stage for different actors from both the public and private sectors, for high-level conventions on development in Tanzania. This year's event focused on the role of technology and the impact it has on society, both now and in the near future.

### **Engagements with Vulnerable Ethnic Groups Self-Identifying as Indigenous People**

Twenty-five meetings were held with Vulnerable Ethnic Groups self-identifying as Indigenous People where four hundred thirty- four stakeholders were reached of whom 134 (29%) were women. Among those meetings, one was a guarter-three traditional leaders meeting which was held at Arusha between 26th and 28th October. This was preceded with a project trip to Tanga and a visit at MST, the Jetty area and the replacement house by fifteen traditional leaders, NGO representatives (UCRT,

Pingos Forum and Paicodeo), Advisor and District Focal person from Handeni, Kilindi, Simanjiro, Kiteto, Kondoa, Hanang, and Igunga.

Apart from general project update, the traditional leaders were capacitated on TSS, Zero Harm safety Cultures, project Induced Immigration as well as Human Rights. Three NGOs (UCRT, Paicodeo & Pingos Forum) supporting capacity building of this group together with advisors attended the meeting.

## **PROJECT INDUCED IN MIGRATION**

The PIIM Working Group (PWG) meetings were held in November in the 3 identified hotspots in the report issued in 2019 (PIIM Situation Analysis Report: CY/ Nzega, Bukombe, and Chongoleani Peninsula) and also in Kahama because of the potential impacts due to the Kakomgwa road use for the pipeline transportation. Indeed, all pipelines are transported from the Dar Es Salaam port to Sojo Coating Yard plant to be equipped with the Thermal Insulation System (TIS) and therefore the truck traffic will increase considerably.

These meetings allowed to share information on the Project activities progress and also on PIIM criteria evolution such as in-migrants arrival in the area, opening of new businesses (guesthouses, restaurants, bars, food shop...), safety road management, security incidents, trend of patient number in health centres,...

EACOP gave the results of the internal guarterly PIIM routine survey conducted in October by the Community Relationship Supervisors and the satellite imagery report with all the main changed detected in the villages close to EACOP activities. PWG members confirmed the results of this routine survey and so far, PIIM phenomenon is well managed without any major impacts in the diffrent hotspots.

Chongoleani peninsula was the area most affected by newcomers' arrival seeking unskilled jobs in EACOP. Thanks to a good collaboration between EACOP site teams, contractors and communities and a clear explanation and a proper implementation of the recruitment process with a priority for the recruitment of the affected communities' members, 95% of newcomers decided to leave the area and to go back home. Changes are expected around Kakongwa road where all trucks transporting the pipelines are going to go by. Drivers will stop for a while in different dedicated parkings and this will certainly attract newcomers with different new business (food, beverages, bars, commercial sex...).

The PWG members also confirmed the quality of the EACOP stakeholder engagement (direct or via contractors) with the affected communities: they have a good information on all EACOP procedures, especially on recruitment process for unskilled/semiskilled and skilled jobs. This is a key information to discourage newcomers from other districts coming to seek unskilled jobs inside EACOP. Regular engagement meetings have allowed us to build trustful relationships which is important to manage properly the PIIM phenomenon and its impacts. Contractors do not start any activity before providing the communities nearby all the information regarding their scope of work, number and profile of jobs for how long and the procedures to apply for a job.

Finally, EACOP PIIM team received the first results of the PIIM campaign on radio, social media and newspapers: the PWG members were very positive and asked EACOP some material to use in their own meetings which was accepted by EACOP. The campaign is focused on fraudulent advertisements, job categories (unskilled, semi-skilled and skilled) and the recruitment process applied by EACOP Contractors for each jobs category. The general audience has well understood the meaning of our messages gualified as clear and without any ambiguity.

This campaign will last until April 2024.
