## REQUEST FOR EXPRESSION OF INTEREST: PROVISION FOR DATA SERVER ROOM, CABLING AND AUDIO VISUAL FIT-OUT. REQ-00000743

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies to express their interest in providing goods and services for the Data server room, cabling and audio visual fit-out to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

### BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

EACOP is seeking a credible service provider to provide the supply of equipment and services for the installation, labelling, documentation, tests, certifications to international standards, and maintenance services of the following fit-out in our Kampala office and future potential similar services on EACOP sites:

#### Technical fit out of the data server room

- Air conditioning system: estimated 24 BTU
- Fire Suppression Clean Agent (FM-200) or Inert Gas (Argon, Nitrogen) System
- Power distribution and emergency shut-down system inside the data server room
- Light: estimated 100 kW led illumination
- Four server/cabling rack cabinets of 42U (800 mm x 1000 mm) equipped each with two 16A Power Distribution Units
- Uninterrupted Power Supply rack-mount units APC 10kVA
- Earthing to connect the rack cabinets to the ground system
- Satellite system (type Inmarsat BGAN or equivalent)

#### Cabling

- Cat6A cabling for about 80 sockets with all accessories- cables, cable trays, trunking, RJ-45 sockets, RJ-45 patch panels – Audio Visual
- Videoconference system Cisco
- TVs and accessories

### MINIMUM REQUIREMENTS

**Companies or organizations expressing their interest are invited to document their request with**

- Certificate of Incorporation, Trading license and other relevant certification

- Proof of registration to the National Supplier Database (NSD) maintained by the Petroleum Authority of Uganda.
- Proof of registration with the Uganda Revenue Authority (URA) and Tax Clearance Certificate for the latest year available.
- Compliance with the Petroleum Midstream National Content Regulations, 2016.
- Experience, performance, and capacity in delivering the goods and services outlined above for data server room and cabling fit out, at a large scale, in compliance with national and international standards.
- Audited Financial Statements for the last three years (Proof of Financial capacity to execute the scope)
- Evidence of a QHSE Management system, organization, and process in compliance with applicable Local and Industry standards for similar works.
- Proof of signed Anti-corruption, Anti-bribery, code of conduct, Compliance and Human Rights policies.
