East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies to express their interest in providing goods and services for Supply of Handtools For Students In a Workshop Setting to the EACOP Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula near Tanga in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE (SPECIFICATIONS)

EACOP is seeking a credible supplier to supply equipment (Hand Work tools) to be used by our Field Operations Trainees. Items required include Sliding hammer puller, Gear puller with bearing separator, Gasket cutting board with cutter sets, Universal press and pull sleeves kit, Hydraulic Jack 10T, Hydrostatic portable hand pump, Feeler gauges dual marked inch and mm, Belt tension gauge, Gasket sheet, Spiral wound gasket with inner and outer ring DN80-150lbs, Manual tubing bender for pipes 1/4, 5/16 and 3/8 inches, Tap and Die Set for Metric and SAE threads, Digital Multimeter, Hart field communicator 475, Digital pressure calibrator, Process Calibrator and Manual pressure and vacuum calibrator.

- Audited Financial Statements for the last three years (Proof of Financial capacity to execute the scope)
- Proof of signed Anti-corruption, Anti-bribery, code of conduct, Compliance and Human Rights policies.
